- 2. Any official who fails to join the new place of posting upon promotion, or voluntarily foregoes the promotion, shall forfeit the right to be considered for any future promotion. In such cases, the next

- eligible official in the order of seniority shall be considered for promotion, subject to fulfillment of all other criteria.

Asstt. as well as other particulars are correct. Variation if any found should be brought to the notice of this office for further orders.

- The DDO shall re-verify that the concerned official has acquired eligible qualification i.e Graduation, with due permission from the competent authority and availed leave as required during the course of study, if any. (for in-service candidates)

6. Before implementing this order, the DDO concerned shall ensure that the incumbent is/are holding genuine appointment for the substantive post in the department
