Subject: Implementation of Uniform Dress Code for Students and Formal Dress Code for Staff in Schools/Offices of School Education Department-District Doda.

# Order No: 24 of CEO Doda Dated: 26-08-2025

As per the instructions received from the Directorate of Samagra Shiksha while releasing funds for Uniform Grant (DBT) under Samagra Shiksha and PM SHRI Schemes, for the Year 2025-26 it has been advised to maintain a uniform dress code across the District, accordingly a committee was constituted to decide upon the Uniform Dress Code.

As such, in order to maintain uniformity, discipline, and a sense of equality among students & in pursuance of the deliberations and resolutions taken in the meeting held on 22.08.2025 in this office, regarding the adoption of a Uniform dress code for students of all Government Schools across the District, and the finalization of an advisory on formal dress code to create a distinct and professional identity for all teaching and non-teaching staff, the following orders are hereby issued for compliance:

# 1. Student Dress Code (Government Schools)

## For Elementary Level

- Light Pink Shirt with Coffee-Coloured Lower.
- **Sweater** shall be of the same colour as the Lower.
- **Dupatta for Girls** shall be of the same colour as the Lower.
- · Black Shoes with White or Grey Socks.
- Tie and Samagra Shiksha Logo on the uniform shall be optional.

#### **PM SHRI Schools**

#### (Distinct Uniform- Elementary Level)

- Beige-Coloured Shirt with Olive Green Lower.
- **Sweater** shall be of the same colour as the Lower.
- **Dupatta for Girls** shall be of the same colour as the Lower.
- Tie and PM SHRI Logo on the uniform shall be mandatory for all PM SHRI Schools.
- Black Shoes with White or Grey Socks.

# Secondary & Higher Secondary Level (All Schools including PM SHRI) For Secondary Level

- Light Blue Shirt with Grey Lower.
- **Sweater** shall be of the same colour as the Lower.
- **Dupatta for Girls** shall be of the same colour as the Lower.
- Sweater same as Lower and Dupatta for Girls as Lower.

#### **Higher Secondary Level**

- White Shirt with Dark Chocolate-Coloured Pant/Lower.
- Sweater shall be of the same colour as the Lower.
- Dupatta for Girls shall be of the same colour as the Lower.
- In both categories, students shall wear Black Shoes with White or Grey Socks.

 Tie and Logo of Samagra Shiksha /PM SHRI as applicable on the uniform shall be optional.

Note: Heads of the Schools are additionally at liberty and may opt / choose one common color combination out of the two suggested above, for Secondary & Higher Secondary classes.

2. Staff Dress Code (Advisory for Teaching & Non-Teaching Staff)

- No specific colour has been prescribed; however, formals only shall be worn, as such, all the staff members of the School Education Department (Schools, ZEO Offices, and CEO Office of Distt. Doda) shall preferably wear formal dress during office/school hours.
- It is also advised for all the staff to wear official Identity Cards during office/school

hours.

- Round-neck T-Shirts are strictly prohibited during office/school hours.
- All Heads of Institutions (Schools/Offices) shall ensure that Dress code for staff shall be complied with immediate effect.

Implementation Mechanism

- All **ZEOs** shall communicate the implementation status of prescribed uniforms to this office **by or before 15th September 2025**.
- All Heads of Institutions shall ensure that parents are duly informed well in advance, so that the decision is implemented from the forthcoming Academic Session.
- Morning assemblies and school notice boards shall be used for sensitization and communication of the approved uniform policy.
- Parents of Students (Class 1<sup>st</sup> to 8<sup>th</sup>) shall be mandatorily informed to **seed Aadhaar with their ward's bank account** to avail DBT transfer of uniform grants, failing which they shall be deprived of these benefits.

The above instructions are issued for strict adherence by all ZEOs, Heads of Institutions, and staff across District Doda.

Any deviation shall be viewed seriously.
