ORDER

Sanction is hereby accorded to the release of funds to the tune of **Rs.23284800/=(Two Crore Thirty-two Lakhs Eighty-four thousand Eight Hundred only)** In favour of the Zonal Education Officers of the District Doda by assigning the Expenditure limit on SNA Account of Samagra Shiksha as approved under PAB 2024-25 for Free Uniforms under RTE Entitlements (Elementary) under Samagra Shiksha as per the breakup given hereunder, for their further disbursement to the eligible students through DBT mode of payment into personal AADHAR linked bank accounts of the students.

The funds are released subject to the following conditions:


- 1 Zonal Education Officers shall make successful DBT of the amount into the accounts of beneficiaries within 07 Days.
- 2 The funds shall be utilized for the purpose for which these have been released after fulfilling all codal formalities and no-reappropriation /diversion at any level shall be allowed.
- 3 The funds shall be released @Rs.600/- per eligible student only through DBT mode.
- 4 Zonal level committee be formed headed by the concerned ZEO to monitor DBT Process and to ensure that all the covered students purchase defined Uniforms for attending the schools, the committee shall certify the action taken within 10 days of the actual DBT made.

- 5 Zonal Education Officers shall ensure that 100% of the eligible students are covered.
- 6 The account and other records shall be open for inspection by any authority as and when required.
- 7 The funds shall be transferred to the beneficiaries through only DBT mode into the AADHAR linked Bank Accounts.
- 8 The parents of the students be directed to purchase the Uniform by adhering to the norms and specifications notified in the Govt. Order No.1383-Edu. Of 2021 dated 24.08.2021 to ensure Uniformity and Quality.
- 9 The fund transfer to beneficiaries shall NOT be made as Vendors in any case , only DBT Mode is to be followed by selecting the appropriate DBT Mission /Scheme code given in the dropdown list on PFMS.
